#### **CHANCELLOR'S REPORT**

Chancellor Robinson provided an update to the board on some things that have transpired since the last board meeting.

- 1. More than 1200 students graduated during the May 19, 2017 Commencement Ceremony.
- 2. The university's redesigned website made its debut on June 1, 2017. The website is student-centered; its functionality and navigation have been improved; it reflects the university's new branding; and gives prospective students a better look at what WSSU is all about.

- 3. WSSU joins the Venture Fund Initiative
  - a. It is a partnership with five other Winston-Salem based colleges and universities whose goal is to build a spirit of entrepreneurship in Winston-Salem.
  - b. Each college/university pledged to incentivize entrepreneurship among their students and alumni through a series of programs based on their areas of focus and unique visions.
  - c. The university could receive over \$100M over a three year period, which would support students and alumni through entrepreneurial efforts that address issues around equity, and other social topics.
  - d. The university has already received a \$50M commitment for the project.
  - e. Through this program, we will be able to leverage the creativity and talents of WSSU students and alumni to help them tackle some of society's biggest challenges.
- 4. The Donald Julian Reaves Student Activities Center won the National Design Award for the Association of College Unions International Facility Design Awards.
- 5. The WSSU Annual Golf Classic held on April 28, 2017 raised \$45M for scholarships.
- 6. The WSSU team won the UNC Staff Assembly Golf Tournament for the 6<sup>th</sup> consecutive year.
- 7. Through efforts of Ms. Mona Zahir, former SGA President, and Mr. Jovanty Hunter, current SGA President, WSSU won the \$30M Retool Your School Grant from Home Depot.
- 8. WSSU's Young Alumni Council recognized its Forty under 40 honorees during their awards gala held in April 2017. The honorees raised \$30m for student scholarships.
- 9. WSSU was selected to mentor other institutions on student success:
  - a. The Foundation for Student Success selected WSSU as one of seven mentor institutions.
  - b. WSSU is paired with 3 mentees- Savannah State University, Langston University, and the University of Michigan-Flint.
  - c. WSSU received \$50M in discretionary funds to assist in our efforts.
- 10. The School of Health Sciences received a \$269M grant from United Way.
  - a. Funds will be disbursed over a three year period.
  - b. The grant will create a program titled Project REACHE, or Rams Employment and Community Health Equity.

- c. The program will assist with improving the health of underserved residents in East Winston.
- 11. Occupational Therapy graduates achieved a 100% pass rate on their state exams.

Chancellor Robinson also mentioned that the university is celebrating its 125 year anniversary and he thanked everyone for all the work that has been done to make WSSU the university that it is.

Chancellor Robinson then turned the floor over to Dr. Brenda Allen for the enrollment report.
