# WINSTON-SALEM STATE UNIVERSITY MINUTES OF THE BOARD OF TRUSTEES MEETING FRIDAY, SEPTEMBER 15, 2017 DRAFT PENDING BOARD APPROVAL

#### **CHANCELLOR'S REPORT**

Chancellor Robinson welcomed all of the new members of the Board of Trustees, and about the informational orientation that was held on Thursday, September 14, 2017. Chancellor Robinson proceeded to invite the board members to the University's 125<sup>th</sup> Anniversary celebration on September 28, 2017. He mentioned the play, the luncheon and the conversation with the Atkins Family, the other activities that will take place.

He then went on to speak about a few things that have transpired since the last board meeting. He mentioned that the university is in its second year of the new strategic plan.

Chancellor Robinson also spoke about the great leadership of the university and the importance of the leadership that will be provided by the Board of Trustees.

Chancellor Robinson then turned the floor over to Dr. Carolynn Berry, Interim Provost, who discussed the enrollment report and enrollment goals.

After Dr. Berry's presentation, Chancellor Robinson stated that the university has already allotted 1.2 million dollars toward scholarships this year. Vice Chancellor Cook then stated that the university has already awarded over 130 Almost Home Scholarships of \$1250.00 or more.

#### **FORMER BUSINESS:**

Vice Chancellor Kluttz-Leach discussed the need to decide which month to hold the Public Comment Session, and the specific terms of the sessions.

There will be five spots available for community members/faculty/staff or students wishing to address the board. Each person requesting time will have 3 minutes to speak.

#### **NEW BUSINESS**

Dr. Harris read the resolutions that will be mailed to former board members, Charles Wright and Osyris Uqoewza, for their service to the Winston-Salem State University Board of Trustees.

Dr. Harris then reminded the board members to register for the UNC Board of Trustees Orientation which will be held on November 1, 2017 in Chapel Hill. The registration link was listed on today's agenda.

**Motion:** Resolved, that the while in Executive Session the board received advice and counsel from Mr. Brown, Chief Counsel to protect attorney client privilege, heard information concerning complaints or grievances, received a report of public records.

Mrs. Henderson moved and Mrs. Nostitz seconded. The motion passed.
