ALUMNI RELATIONS

- Coordinated another successful 40 Under 40 Awards Gala. WSSU and the Young Alumni Council honored 40 outstanding young alumni at the April 8 event.
 - o Over 350 people attended the Gala
 - o Contributions totaled \$30.309; gross ticket sales totaled \$12,195
- Class Reunions
 - o Working with the following class groups: 1962, 1967, 1977, 1982, 1987, 1992, 1997, 2007 and 2012.
 - o 50th Class and 25th Class are funding endowed scholarships

ANNUAL FUND

- Completed Spring Call Program
 - Increased credit card pledges
 - 445 in 2017 vs 412 in 2016 (31.4% increase)
 - o Increase in instantly fulfilled gifts by credit card was the largest
 - \$60,426 in 2017 vs. \$48,003 in 2016
 - Worked with marketing for press and social media features
- Continued solicitations for the 2017 WSSU Foundation Golf Classic held April 28, 2017
- Attended 2017 Case Conference in Nashville, TN
- Partnered with WSNC 90.5 Radio for Spring on-air campaign
 - o Worked with Interim Director, Ben Donnelly, to identify goals for campaign
 - o Requested reports from Donor Services to identify potential and current donors
 - Coordinated marketing efforts for advertisement to current & potential donors and social media posts
 - o Lead volunteer efforts for assistance with donor calls and on-air pitches

- Partnered with the Student Government Association (SGA) President, Mona Zahir, her cabinet, and the Chancellor to host the first SGA Thank-a-thon for donors
 - Created script for students

 - o Interacted with donors on social media during calls

CORPORATE AND FOUNDATION RELATIONS

- We are in the final stages of securing a seven-figure gift to launch the Center for the Study of Economic Mobility, which will support faculty and undergraduate research and strategic priorities focused on social justice.
- We hosted AT&T executives on campus for "AT&T Academy" on April 13. AT&T executives
 facilitated sessions focused on critical thinking and communication skills and provided faculty
 with opportunities to learn how essential skills taught at WSSU are demonstrated and observed in
 the workplace. As a next step, WSSU will craft workshops and case-studies to use for professional
 development programs at WSSU.
- We hosted Toyota Financial Services executive John Ridgeway on campus in April during the annual scholarship luncheon. Mr. Ridgeway is introducing WSSU to additional partners and funders. Michelle Cook is working with academic affairs to move these conversations forward.
- We hosted SAS executive Oita Coleman on campus in May to explore opportunities for partnership
 – including opportunities for SAS to recruit WSSU students for internships/jobs and to provide
 resources for curriculum development through SAS University.
- We hosted a "Breakfast and Conversation with Chancellor Robinson" for Triad-area corporate and foundation executives on May 10. This was an opportunity to engage partners and funders in WSSU's work to advance healthcare and strengthen the local community.
